Academic Affairs Council Meeting August 20, 2024 Summary and Action Items

Graduate Admissions Deadlines – TXST Global Admissions would like to propose standardizing the
application deadline dates for fall, spring and summer terms. Currently there are 79 different deadlines
applicants must navigate to successfully apply to The Graduate College. Establishing a singular, frontfacing priority date for funding and application consideration allows the university to recruit, market,
and attract applicants to The Graduate College. Similarly, setting an application deadline for each term
will maximize the time frame for prospective students to apply. Programs, namely those with limited
capacity concerns, may request their application be closed any time between the established priority and
application closing deadlines.

The proposed application priority and closing dates to be posted on all program pages are as follows. They are the same for domestic and international applicants.

The Council endorsed this proposal. This item will now be brought to the Graduate Council for consideration.

- 2. New full-time definition for master's students Dr. Andrea Golato shared with the Council an implementation task list of administrative changes and communications necessitated by the change in the TXST definition, effective fall 2024, of full-time enrollment for all master's students to a minimum of 6 credit hours per semester (and half-time at 3 credit hours).
- 3. **Bobcat Bounty** Dr. Angela Ausbrooks spoke to the group about broadening the work of Bobcat Bounty and moving it from a school level to university level initiative. If anyone has any initiatives or ideas to bring more awareness of the importance of TXST's Bobcat Bounty, please contact Dr. Ausbrooks directly.
- 4. **Signed/Approved Documents** Dr. Aswath asked the deans to remind their units of the seriousness of manipulating documents that have already been signed and approved and should never be done.
- 5. **Promotion Process for Faculty of Instruction** Dean Fleming asked on the process for FOI promotions going forward. It was mentioned that a specific university policy is in draft and will be sent out for review addressing NTL promotions starting in the FY 26 promotion cycle. It was discussed that FOI promotions will now be completed via the Faculty Qualifications system and comply with the published promotion calendar by FAR annually.
- 6. Adjunct Pool for the Round Rock Campus Dr. Aswath presented a proposal to the deans regarding creating an adjunct pool specifically for the Round Rock Campus that Dr. Lessiter could manage; hiring decisions would still be made by the respective dean. The deans were in agreement and discussion was held on how this process would work.
- 7. **Phi Beta Kappa Update** Dr. Heather Galloway provided a brief update on TXST being awarded a Phi Beta Kappa chapter. TXST is now only the fifth public university in Texas to have been awarded a chapter. PBK scholars will be inducted starting spring 2025.

- 8. Undergraduate Admissions Report Mr. Gary Ray provided the Council with an undergraduate admissions report. He shared highlights from undergraduate admissions activities and registration.
 - The final new student orientation catch-all session is today in San Marcos.
 - This fall, we have disbursed over \$158.4M for 25,199 students' registration bills. This is an increase of \$10.2M (6.9%) and 3,092 (+14%) students, respectively, compared to last fall.
